The Secretary shall convene the meeting. The College Council shall meet minimum 4 times in a year as per the NCISM regulation and the minutes shall be

recorded.

The college council shall also organise regular interdepartmental meetings like grand rounds, statistical review meetings, clinical meetings and research review in the institution regularly.

The college council shall plan, review and upgrade academic, healthcare, research and co curricular or extra curricular activities of the instituion, strategic planning and implementations, students performance and improvisation.

The college council shall develop vision document of the Institution and periodically monitor its implementation. And council shall review academic audit report of the Institution as per the guidelines of the commission and the Institute shall submit the academic audit report in the prescribed format in such manner to the commission within the timeframe, specified by the commission from time to time.

The decision of the College Council shall be taken by a simple majority and in case of equality of votes the chairman shall have second or casting votes. Where the Principal overrules the decisions of the College Council, the Secretary shall report the same to the Vice Chancellor. The College Council shall be reconstituted every year.
