ORDER

- 1. University, notification read (1) above, invited applications for Continuation of Provisional Affiliation for the academic year 2025 - 26 from the colleges for the courses affiliated to the University.
- 2. Vide paper read (2) above, Principal Vaidyaratnam PS Varier Ayurveda College, Kottakkal submitted their application with necessary documents.
- 3. Subsequently, University carried out an inspection at the college to assess the facilities available for conducting UG, PG courses for the AY 2025-26 and the inspection commission submitted its report vide paper read (3) above.
- 4. The Scrutiny committee held on 22.04.25, verified the inspection report and noticed some minor deficiencies. Hence the same were intimated to the college for rectification as per the letter read (5) above.



- 5. In response to the same, the Principal submitted a compliance report read (6) above and the same was scrutinized by the scrutiny committee on 22.05.2025 and found satisfactory. Thereby, the committee recommended to grant Continuation of Provisional Affiliation to the college for conducting UG & PG courses for the AY 2025–26.
- 6. Vide decision read (7) above, 84th Governing Council resolved to grant Continuation of Provisional Affiliation to Vaidyaratnam PS Varier Ayurveda College Kottakkal for conducting BAMS course with 63 Seats, 07 PG courses with 45 seats & 04 PG Diploma courses with 10 seats for the AY 2025–26, subject to the receipt of Letter of Permission from the NCISM, Govt. of India, Ministry of AYUSH.
- 7. Vide paper read (8) above, the Medical Assessment and Rating Board for the Indian System of Medicine (NCISM), Ministry of AYUSH, Govt. of India has extended yearly permission to Vaidyaratnam P S Varier Ayurveda College Kottakkal with an intake capacity with 63 seats in UG(BAMS) course in accordance with Regulation 54 (2) of MESAR UG Ayurveda 2024, granted extended permission to 07 PG courses MD (Manasaroga and Manovijnana) with 9 seats, MD (Agada Tantra and Vidhi Vaidyaka) with 5 seats, MD (Dravyaguna Vijnana) with 6 seats, MD (Panchakarma) with 6 seats, MD (Swasthavritta and Yoga) with 6 seats, MD (Samhita and Siddhanta) with 4 seats, MS (Shalya Tantra) with 4 seats, in accordance with Regulation 15 (5) of MESAR PG Ayurveda 2024 or the academic session 2025–26.
- 8. Accordingly, orders are hereby issued granting Continuation of Provisional Affiliation to Vaidyaratnam P S Varier Ayurveda College Kottakkal for conducting below mentioned UG & PG courses with intake capacity as per the Letter of Permission issued by NCISM, Govt. of India for the AY 2025–26 & implementing the Governing Council decision:

- i) The college shall comply with the conditions prescribed by the Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine, in the permission order granting permission to the college for conducting UG, BAMS & PG courses during 2025-26 vide letter read (8) above.
- ii) Selection, admission and collection of fees shall be made only on the basis of the rules and regulation of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- iii) In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- iv) Affiliation granted is strictly provisional and only for the academic year 2025-26. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- v) The College should remit balance annual administration fee fixed for UG & PG courses for the academic year 2025-26, if applicable.
- vi) Admission to the next academic year shall be made only after obtaining prior permission from the University.
